## Liquor Control Commission August Underage Compliance Report

SPRINGFIELD – In August of 2017, the Illinois Liquor Control Commission (ILCC) conducted compliance checks around the state and visited 84 businesses licensed to sell liquor. They cited 13 for violations of liquor control laws.

This is a monthly aggregated report of all the underage compliance investigations conducted in the month of August. The ILCC may release results on individual investigations through shorter press releases throughout the month.

The monthly aggregated report lists all of the results of ongoing undercover and cooperative law enforcement operations conducted by Illinois Liquor Control Commission (ILCC) agents, local law enforcement officials and volunteers from high schools and colleges. The teams randomly visit liquor stores, restaurants and bars in communities around the state to check for ongoing compliance with state laws mandating that no liquor is sold to minors under the age of 21. ILCC agents also work with local and state law enforcement agents to focus on communities with a high incidence of underage liquor sales.

**Below is the bulleted list by location of which establishments violated the law by selling alcohol to ILCC underage participants. Because the visits are random in nature, certain areas of the State are visited at certain times of the year.**

**EVANSTON** – August 11th, the ILCC and the Evanston Police Department conducted underage alcohol checks. Of the 16 licensees checked, none sold alcohol to ILCC underage participants.

**BURBANK** – August 24th, the ILCC and the Burbank Police Department conducted underage alcohol checks. Of the 16 licensees checked, three sold alcohol to ILCC underage participants. Those licensees were:

**LINCOLNWOOD** – August 30th, the ILCC and the Lincolnwood Police Department conducted underage alcohol checks. Of the 15 licensees checked, three sold alcohol to ILCC underage participants. Those licensees were:

- CHIPOTLE MEXICAN GRILL #1827, 7150 N MCCORMICK BLVD, LINCOLNWOOD, IL 60712
- RED LOBSTER #582, 3301 W TOUHY AVE, LINCOLNWOOD, IL 60712-2716 (1 prior violation)
- CVS PHARMACY #8749, 3950 W DEVON AVE, LINCOLNWOOD, IL 60712

**MANTENO** – August 31st, the ILCC and the Manteno Police Department conducted underage alcohol checks. Of the 19 licensees checked, three sold alcohol to ILCC underage participants. Those licensees were:

- MIDTOWN WINE & SPIRITS, 83 W FIRST ST, MANTENO, IL 60950 (1 prior violation)
- CIRCLE K #183, 29 S LOCUST ST, MANTENO, IL 60950-1515

**WAUCONDA** – August 31st, the ILCC and the Illinois State Police District 2 conducted underage alcohol checks. Of the 18 licensees checked, four sold alcohol to ILCC underage participants. Those licensees were:

- LUCKY VINE, 451 W LIBERTY ST, WAUCONDA, IL 60084-2452
- BLISS WINE AND GIFTS, 201 S MAIN ST, WAUCONDA, IL 60084-1800
- CITGO GAS STATION, 1200 N RAND ROAD, WAUCONDA, IL 60084 (2 prior violations)
